

Bowhead provides quality and comprehensive marine and shoreside services on passenger, freight and research projects world-wide.

Bowhead is an SBA-certified 8(a) Alaska Native Corporation (ANC) and in accordance with Federal Acquisition Regulation (FAR) clause 15.305 (a) (2) (iii) eligible for Direct Award Contracts (DAC). Bowhead provides a DCAA/DCMA audited accounting system.

#### **Maritime Services**

Bowhead provides turn-key vessel maintenance services to the Strategic Weapons Facility Atlantic at the Naval Submarine Base (NSB) at Kings Bay, GA. A team of 14 Bowhead boat maintenance specialists maintains 18 vessels ranging in size from 33 to 64 feet. The program has a high level of visibility requiring the repairs be completed in very short availability periods. 12 of the vessels are owned by the U.S. Navy and operated by the U.S. Coast Guard.

Bowhead's Project Manager (PM) works closely with the Navy Contracting Officer's Representative (COR) to ensure that the maintenance requirements on the 12 vessels owned by the Navy, but operated by the Coast Guard are fully addressed to ensure vessel readiness. The remaining six (6) vessels are specialty harbor security vessels, which operate continuously 24/7. These are also maintained to the required high level of readiness.

# **Marine Support Services**



# U.S. Coast Guard's (USCG) Aviation Training Center

Bowhead operates and maintains two utility vessels in support of the USCG Aviation Training Program at Mobile, AL. Bowhead's PM plans, schedules, coordinates and ensures the timely completion of each mission and all maintenance functions. The Bowhead team performs all predictive, preventive, and corrective maintenance as well as completing all depot level maintenance and yard period for the vessels. The PM has the discretion to use technical assistance when necessary to ensure mission readiness. He ensures that all operations are completed safely, within the corporate safety program guidelines, and in accordance with USCG requirements for mariners.

## **USMC Amphibious Vehicle Test Branch (AVTB)**

Bowhead operates and maintains multiple high-speed 10/11 meter Rigid Hull Inflatable Boats (RHIBs), 27ft USMC Boston Whaler, and a 64ft Workboat as support and rescue platforms for the United States Marine Corps (USMC) Expeditionary Fighting Vehicle testing and evaluation program in Camp Pendleton, CA. The Bowhead vessel operators are USCG licensed mariners and/or have a minimum of 10 years' military experience working and maintaining small boats, with significant training and experience in high speed vessel operations, military command, communications and control, diving support operations, at-sea military search and rescue and helo/stokes medical evacuation at sea.

#### Naval Submarine Support Command (NSSC)

The Bowhead Hawaii Torpedo Weapons Retrieval (TWR) and Port Services teams operate and maintain three torpedo retrieval crafts at NAVSTA Pearl Harbor, HI. The vessels are operated and maintained 7 days-per-week by a Bowhead crew. The Port Services staff monitors all applicable radio channels, maintenance of ships and facility logs, monitor waterfront activities and vessels including Fire and Flooding Watch 7 days-per-week, and arranges for vessel services including pilotage, dockage, portable water, shore power, trash and garbage removal, CHT and HAZMAT removal, line handlers, and other portside services as requested by the government.

#### **Shoreside Services**

#### **Naval School Explosive Ordnance Disposal**

Bowhead provides the USCG certified crews and maintenance staff to operate and maintain vessels in support of the U.S. Explosive Ordnance Disposal (EOD) School at Eglin AFB, FL. Bowhead's employees also manage the port operations and waterfront administration. These services are provided on a "turn-key" basis, with Bowhead providing the management expertise, personnel, supplies, tools, equipment and vehicles.
